CU Family Health Clinic (previously Sheridan Health Services) is operated by the CU College of Nursing and offers primary care, urgent care, behavioral health, pediatrics, and dental. The on-site closed-network pharmacy fills prescriptions from clinic providers and pharmacy students work under Chronic Disease State Management (CDTM) protocols to manage medication therapy for patients with diabetes, hypertension, hypercholesterolemia, and obesity.

# COMMUNITY-BASED PHARMACY RESIDENCY PROGRAM

This Post Graduate Year 1 (PGY1) residency program provides the opportunity to participate in progressive community pharmacy practice. The resident will be exposed to all aspects of clinical pharmacy practice, business management, marketing strategy, and operations.



Our resident will gain valuable experience in both a community pharmacy setting as well as in ambulatory care and will assist in the creation and implementation of various new programs. Our focuses include medication access for underserved populations, chronic disease state management (CDTM) protocols, administration of therapeutic injections (primarily Vivitrol), and the expansion of our pharmacy services to new sites. The CU Family Clinic at Sheridan prides itself on its commitment to interprofessional collaboration, and residents will work with on-site pediatrics, primary care, behavioral health, and dentistry providers to make recommendations and ensure clinic patients get appropriate treatment. In addition, our resident will spend two days weekly at Denver Indian Health and Family Services working under Chronic Disease Therapy Management protocols to help manage patients with chronic disease states including diabetes and hypertension
