



PGY2 Ambulatory Care Pharmacy Residency

UCHealth-University of Colorado Hospital/University of Colorado Skaggs School of Pharmacy (ASHP Accreditation #82155; NMS Program Code 514165)

This PGY2 pharmacy residency program builds on Doctor of Pharmacy education and PGY1 pharmacy residency programs to contribute to the development of clinical pharmacists in the specialized area of ambulatory care practice. PGY2 residencies provide residents with opportunities to function independently as practitioners by conceptualizing and integrating accumulated experience and knowledge and incorporating both into the provision of patient care. Residents who successfully complete this accredited PGY2 pharmacy residency are prepared for advanced patient care, academic, or other specialized positions, along with board certification in ambulatory care. Graduates of this program are qualified to practice as a clinical pharmacist and/or become a faculty member at a School of Pharmacy or Medicine.

The University of Colorado is an interprofessional, state of the art academic medical center. Our residents have robust clinical training and educational/academic experiences. Residents gain experience in medical writing and publishing, complete a research project of publishable/presentable quality, and are involved with practice management activities.

Family Medicine*	This clinic site is the School of Medicine's interdisciplinary AF Williams Family Medicine clinic and enables a well-rounded experience with a wide variety of patient populations (e.g., children, adults, elderly, pregnant patients) and providers (physicians, medical residents, nurses/nurse practitioners, physician assistants, psychiatrist/psychologists, and health sciences trainees). Clinical pharmacists provide team-based care, consultative services, direct patient care under collaborative drug therapy protocols, and education.
Geriatrics	The Senior's clinic at the University of Colorado Hospital cares for patients age ≥75 years.
Primary Care*	Several primary care clinics within UCHealth where clinical pharmacists provide care. These include internal medicine and family medicine options, where some also serve as medical resident training clinics.
Population Health – CU Medicine	This experience extends to CUmedicine, which is the physician management group for all School of Medicine providers. Activities include both administrative and clinical care aspects of population health.

The Teaching Certificate Program and A Structured Program to Guide Residents' Experience in Research are required.

REQUIREMENTS: Doctor of Pharmacy Degree (ACPE accredited), PGY 1 residency, Pharmacist licensure in Colorado throughout the duration of the PGY2 program

BENEFITS: Salary is \$65,588 (2024-2025 stipend). Benefits include: healthcare, 22 accrued vacation days (and select holidays), and a travel stipend. Residents are appointed as Clinical Instructors with the School of Pharmacy.

APPLICATION: Interested applicants should provide a letter of intent, CV, academic transcripts, and 3 letters of recommendation using the ASHP Pharmacy Online Residency Centralized Application Service (<http://www.ashp.org/phorcas>). The application deadline is January 3.
