### Gift Announcement

Please join in celebrating a \$3 million grant from The ALSAM Foundation to the CU Skaggs School of Pharmacy and Pharmaceutical Sciences. This grant will fund four therapeutic innovation research projects in the school that focus on specific disease states and the development of their most promising therapeutic treatments. ### Senate Bill 16-135 Expands Opportunities

On June 6, 2016, Governor Hickenlooper signed Senate Bill 16-135 into law while sponsors of the bill (Representative Joann Ginal), and

representatives from the Colorado Pharmacists Society, CU Skaggs School of Pharmacy and Pharmaceutical Sciences, and Regis University School of Pharmacy watched. The bill amends both the Pharmacy Practice Act and the Colorado Insurance Code to expand practice opportunities for pharmacists, and provides a pathway for reimbursement of pharmacy services.
